1. The Scholarship shall be payable from the date of admission of the students to the M.Sc. 1<sup>st</sup> & 2<sup>nd</sup> semester up to the last date of examination or 12 calendar months, whichever is earlier;
2. The progress of scholarship holders shall be monitored by the Head of the Department/Coordinator and due consideration shall be given to seminar work of the student/s, in case it is established by the Department that the scholarship holder does not maintain the required progress, the scholarship granted to him/her may be withheld;
3. The award of scholarship shall be subject to the condition that student attendance not be less than 80% of the total number of lecturers, tutorial/ practical work and seminars and good conduct;
4. No student who is in receipt of any other scholarship or stipend including National Loan scholarship from the state or the central Govt. of the UGC shall be eligible for grant of PG Merit scholarship. However, students in receipt of any such scholarship or stipend shall be required to surrender one of the two scholarships. Necessary undertaking shall be secured from the students to this effect before any part of the University scholarship is paid to him/her by the Head of the Department / Director/Coordinator.
5. The eligibility of the student shall be verified by the Head/Director/Coordinator of the Department concerned.


